
CHANGES TO ROAD SAFETY AUDITING IN AUSTRALIA AND NEW ZEALAND

Austroads has just released an update to the Guide to Road Safety (AGRS) Part 6 (2022) Road Safety Audit. The new Guide replaces the old Part 6 & 6A. The guide was prepared by Paul Hillier (ARRB) and project managed by Joseph Le (TfNSW) and Kenn Beer (Safe System Solutions Pty Ltd).

WHAT ARE THE KEY CHANGES?

- ✓ Formal recognition of Safe System Assessments within the lifecycle of an infrastructure project.
- ✓ Reinforcing the need for a team of auditors (ie. no one person Audits).
- ✓ Further clarity on the independence requirements of Road Safety Auditors.
- ✓ New case studies and examples.
- ✓ Importance of 'closing the loop' and learning from RSA outcomes.
- ✓ Importance of road managers/authorities having an RSA policy.
- ✓ New risk matrix with enhanced Safe System energy tolerance:

- ✓ Relaxed requirements for night inspections as part of feasibility stage RSAs.
- ✓ Detailed information about thematic (specialist) audits motorcyclist, pedestrian and cycling.
- ✓ Clarity around what a Traffic Management Road Safety Audit is as opposed to a Compliance Audit or surveillance check.










- ✓ Establishment of three levels of Road Safety Auditor: **Senior Auditor**, **Auditor** and **Trainee**. (Team Leader must be a Senior Road Safety Auditor).
- ✓ New progression requirements: 2 x Audits to become an Auditor, 5 x design stage Audits to become a Senior Auditor.
- ✓ Skills, experience, knowledge and attitude requirements of Auditors.
- ✓ Recognition of the use of Control Data as appropriate.
- ✓ Specific local government advice.
- ✓ Another step towards national harmonization.
- ✓ Specimen Code of Conduct for Road Safety Auditors.
- ✓ Updated Prompt Lists (previously called checklists).
- ✓ Requirement to embed Safe System principles into the Audit Findings: ie. Biomechanical tolerance of the human body.
